OPEN LETTER AN OPEN LETTER TO THE BOULDER COUNTY BUSINESS COMMUNITY FROM JEAN LUND AND JOSIE HEATH Protect Yourself from the Political Winds: Sustainable Investments for the Long Term

By the time you read this, we will know who won the presidential election. But, for the purposes of this Open Letter to the Business Community, it doesn't matter who won.

True, we must be agile enough to adjust to periodic adjustments in political winds, as well as changes in the social and economic climate, and the impacts they have on our business operations or community needs. However, we also know the climate will soon change again. That is why, more important than dealing with the present circumstances, the real secret to success lies in our long term strategic investments, including philanthropy, that keep us strong no matter which way the wind is blowing.

A case in point was our community's response to the tragic Fourmile Canyon fires in 2010. The victims of that disaster suffered the terrible destruction of personal property along with the less tangible, but often more painful, loss of irreplaceable family history and the connection to fond memories. Our economy also took a short-term hit as businesses dealt with everything from the absence of critical employees to the

disruption of normal government services.

Fortunately, Boulder County had the resources in place to ease our recovery from the Fourmile Canyon fire. Everything was available from emergency relocation services to grief counseling due to prior funding commitments, helping to speed the healing from an awful community tragedy.

The Community Foundation was proud to play its own part as a resource for effectively and efficiently distributing financial contributions to fire victims. Again, consistent annual contributions that keep our organization strong, not one time emergency funding, was the foundation for the Community Foundation's critical role in our response to the Fourmile Canyon fire.

The lesson here is age-old, but worth remembering, the investments we make today are the seeds of our future success. Our effective response to the Fourmile Canyon fire would not have been possible without sustained attention to community needs.

It is in this vein that we should all be disturbed by reports that charitable giving as a percent of income in Boulder County has dipped below the

rate for all of Colorado. We also lag behind the giving rates in the higher income levels amongst our pier cities, such as Ann Arbor, Austin and Eugene.

Circle of Care

Matchmaker turn isolation into inclusion, reconnecting elders with their community

BOULDER — Coloradans have to work hard to become bored with nothing to do.

From outdoor recreation to cultural art programs, the choices available stretch farther than the day is long. For many, however, unyielding barriers stand in the way of enjoying and participating in things in which the rest of us take pleasure.

Homebound elders and senior-facility residents who don't have transportation, for example, tend to be limited in how and where they spend their days. If they have physical, cognitive or financial challenges on top of that, the chances for being active and involved in the community are reduced even more.

The results can be isolation, depression and withdrawal.

It's easy to forget that these people have

contributed and helped create the local environment in which we delight. They've raised children here, taught in our schools and set the tone for the foundation that sets Colorado apart from the rest of the world. When our elders are out of circulation, we lose their voices, experiences and gifts.

Joan Raderman, who sees herself as a matchmaker, saw the win-win potential of reconnecting elders to the community and responded to it by bringing Circle of Care to life in 2004. Since then, the nonprofit organization has rekindled passion for life in elders, provided access to classes and events for volunteers and blended the knowledge of multiple generations into a new kind of community.

Circle of Care keeps the question "who's helping whom?" in motion.

Without involvement, people generally retreat into isolation.

"What causes elders to isolate includes not having the money to do anything extra, no transportation to get there if they did, physical or cognitive decline and not having a buddy to do things with," Raderman said.

She referred to CU-Boulder's Senior Auditor Program, which allows Colorado residents age 55 and older to sit in on most classes for free, as an opportunity that comes with hidden barriers for some.

The challenge of registering for a class online, getting transportation to the university and negotiating a walk to the classroom with a cane or a walker can turn the opportunity into a pipe dream.

If that person has a companion/partner who helps reduce the difficulties, however, the opportunity turns into a stimulating

activity.

Raderman described the Circle of Care protocol as incentivized civic engagement. She has worked with CU, for example, to allow elders who have physical and technical challenges to participate in the auditor program with a companion/partner. One appeal to the volunteer is the opportunity to audit the classes with the elder.

Other events aimed at ending isolation and community involvement include free tickets to films and cultural programs such as the Colorado Music Festival, Boulder Philharmonic Orchestra and Colorado Shakespeare Festival.

Volunteer/companions receive the same free ride as their elder partners in these outings as well.

"Soon it becomes personal to volunteers, and there's a shift that goes beyond the tickets," Raderman said. "Volunteers become family."

Some volunteers see the opportunity to attend events outside of their own budgets as an additional benefit.

"There's one woman, a single mother in

school, who wants to give her kids experiences she can't afford," Raderman said. "The kids are taught how to help elders when they attend, in addition to having access to resources they wouldn't have had the opportunity to." Raderman partners with more than 50 arts and cultural organizations to be able to offer free entry to more than 200 events yearly. She's also looking to work with organizations such as Head Start, which provides



Partnership's safety net for at-risk youths aimed at heading off future problems

ounties in Colorado provide a matrix of services to help at-risk youths and prevent a raft of future problems.

Boulder County interlaces such services among an 11-agency collaboration catching at-risk youths in a web of care that leads to better outcomes and safer communities. After 14 years of dedicated, results-driven work, Boulder County IMPACT was named the 2012 Colorado Collaboration Award winner by the Colorado Nonprofit Association.

at risk so they do not become part of the justice system as adults," said Renny Fagan, president and chief executive of the Colorado Nonprofit Association. The association supports Colorado nonprofits through education, training and advocacy in the Legislature.

Boulder County IMPACT, or Integrated Managed Partnership for Adolescents and Child Community Treatment, serves juveniles at risk of being removed from the home because of criminal behavior, mental-health problems or other home welfare issues, said Susan Caskey, executive director of the organization.

IMPACT blends staff resources, funding and services among its partner agencies in a rich, sharing model, Caskey said. The organization served 850 youngsters last year with 70 percent of the youths

entering IMPACT through the juvenile justice system.

"We spend eight hours a week as a collaborative, talking about specific kids and families and coming together to bring all the agencies' expertise and provide options," Caskey said. The team identifies underlying causes of criminal behavior and then prioritizes the right intervention. For example, a student entering the system for drug use might face underlying issues at home, such as a lack of food, safety or other basic needs — issues that must be addressed for treatment to be effective.

"For any of us, it would be very hard to focus on therapy if we weren't eating," Caskey said.

It's a consistent, cohesive, priority-driven approach to intervention that creates less confusion for youths and families and doesn't feel as overwhelming, she said. Rather than being inundated with expectations from separate agencies, participants get a consistent message across the board. It's a system that works, too, with Boulder County committing youths to out-of-home placements at a lower rate than the rest of the state.

From 2004 to 2011, data collected by IMPACT and the state of Colorado showed commitment rates in Boulder County fell to nearly one-third the Colorado rate, said Caskey. IMPACT collaboration doesn't just save children from deten-

Changing the world

Association for Community Living gives hope to people society forgot

hen Ailsa Wonnacott, executive director of the Association for Community Living, recently made her annual appeal for funding to the Boulder County Commissioners, she brought

along a powerful message.

In her office in rural Longmont, Wonnacott keeps the cardboard sign she brought to that meeting. On one side, her team created colorful images of all the work ACL does to advocate on behalf of children and adults who live with developmental disabilities, ranging from training young parents to fostering changes in public policy.

On the other side was a coarse image of a tiny, rundown building behind a chain-link fence. Earlier this year, the association discovered 10 people with disabilities living in the studiosize outbuilding, another living in a shed outside, and a couple in a makeshift tent.

"This is not a refugee camp," Wonnacott said. "That is downtown Longmont last Thursday afternoon. For some people, the only safety net is us, and that's only if we can find them."

At its heart, the association is dedicated to ensuring that all

members of the communities in Boulder and Broomfield counties are able to live, work and participate fully in all aspects of community life. It began as a grassroots movement supported by Boulder parents in the early 1960s that grew into the local chapter of the community-based organization The Arc. This year, the association celebrates its 50th anniversary.

"This movement has grown from a few parents meeting in a living room to being an organization that helps change the world," Wonnacott said. "But of course, as we change the world, the world changes in all kinds of ways that we can't predict."

In fact, those changes represent serious obstacles to the people her organization serves. While access to public education has improved over the decades, other challenges have exploded in the past five years.

Among these hurdles are a crisis in funding for adult services, a tsunami of aging caregivers for children with disabilities, increased rates of autism spectrum conditions, protracted wait times to access services, and potentially devastating cuts in funding for elementary and secondary education.

"Cuts in education impact students without disabilities significantly, but they impact students with disabilities catastrophically," Wonnacott said. "If there are fewer adults in a school, students will not have the support they need to attend general education classes, let along benefit from individualized help."

The agency, a 501(c)3 nonprofit, partners extensively with school districts in Boulder and Broomfield counties and with other service providers such as the Boulder-based Community Centered Board, better known as Imagine! With just eight staff members and some 200 volunteers, the association provided advocacy, referrals and training to more than 1,200 people with disabilities and their families in 2011.

The community is vital to the agency's financial success. With a budget around \$650,000, fully half of the association's budget comes from the funds provided through Arc Thrift Stores throughout the state.

"The Arc Thrift Stores are absolutely key to our survival. We always tell people to please buy there, and donate there," Wonnacott said.

One of the association's clients was

able to rebuild from homelessness by working in one of the thrift stores and securing a donated vehicle from Arc.

The community can help support the association's work in

other ways as well. The nonprofit offers membership ranging from \$2 for people with disabilities to \$500 for a lifetime membership, and welcomes individual donations. The organization also values its many volunteers. Opportunities range from helping at the office with training and events all the way to more intensive

advocacy efforts.

"We need as many volunteers as we can get," said Kristine Johnson, training and events coordinator. "We're just getting our volunteer advocate program off the ground to foster friendships and activities between volunteers and people with disabilities. These volunteers truly contribute to social

tion, she said; it also saves money. Boulder County accounts for about \$1.3 million in annual expenses for committed young people compared with the estimated \$4.3 million it would cost Colorado if the county mirrored statewide patterns.

IMPACT's collaborative model has received national recognition, too, Caskey said, and inspired Colorado state legislation. House Bill 1451 provides incentives to counties creating similar collaborations, she said.

The Colorado Collaboration Award, in its second year, comes with \$50,000, Fagan said. IMPACT plans to use the money to improve results through research-based intervention and constant vigilance when weeding out what doesn't work and nurturing what does.

"We are always evolving and not trying to fit families to services that don't really fit them," Caskey said. Research shows early intervention and prevention reduce incarceration rates, and IMPACT plans to incorporate more of each into its plan.

Jacalyn Whittington is the director of stu-

dent services for the St. Vrain Valley School District. She coordinates the majority of services outside of traditional education, such as truancy and drop-out prevention resources, gifted and talented programs and special education. For the past three years Whittington has represented the school district on IMPACT's collaborative board. She brings 35 years of experience in education to the table and believes in the organization.

"I've never worked in a school district that has had this type of collaboration," Whittington said. "It's what all educators strive for but don't know how to be a part of."

Other counties in Colorado and other states strive to do what Boulder County IMPACT has been doing for years, she said.

The consistent, inter-agency collaboration's unified message focuses on students' strengths rather than punishing their weaknesses, Whittington said, calling it something that produces more effective outcomes and long-term student success.

"It's really kind of an overwhelming experience just to see people dedicating a significant portion of their time outside of their regularly assigned job and looking at not just to what do I need to be responsible for, but what is the greater good, the bigger picture," Whittington said.

Research shows that even a short time in jail increases the chance of recidivism, she said, while keeping youths out of jail and in school means a safer community in the future.

"When we have well-educated kids, they are going to give back to our community when they finish high school because they are engaged in it and attached to our community."

change as part of a team of dedicated, compassionate individuals."

The people at the association also work to change public perceptions of people with disabilities.

"People with disabilities are not passive recipients of care or a drain on public dollars," Wonnacott said. "They are active, contributing members of our community. The degree to which we can provide the appropriate and necessary support, the more we benefit as a community."

The association's goals are not about creating dependency but instead helping families, caregivers and people living with developmental disabilities to foster confidence in their own ability to advocate for themselves, and to promote self-sufficiency.

"I think it's really important for people here to understand that we're a human rights organization," Wonnacott said. "We have a long way to go in protecting the civil rights of people with disabilities. The association is often the only organization that stands between the happy, healthy and safe life a person should be leaving, and living in a makeshift refugee camp. We get people to the table and ensure they are given the opportunity to speak. When they cannot, we will speak for them."

comprehensive services — from education to nutrition — to low-income families and their children.


"I have elders who've spent their lifetime in education and are begging to be part of this volunteering in the classroom," Raderman said, referring to matching of elders with children as a win-win situation. "My work is as the connector."

Working with a \$250,000 annual budget, Raderman, who has a background in health-care administration and medical marketing, admitted that her reach is limited even though her ideas are not. "We could easily quadruple what we do if I had the resources."

Raderman hopes to inspire business sponsors and corporate underwriters to use her program as a way to increase their community visibility and "to work for the greater good."

Pro-bono business developers, private donors, complimentary ticket donations and volunteers are needed to stretch the Circle of Care reach.

"This is more of a movement than a program," Raderman said. "We're building a healthier, more inclusive community that makes all of us feel that we belong to something."



GIVING GUIDE 2013 GLOSSARY of Nonprofit Terms

ADVISED OR DESIGNATED FUND

A fund held by a community foundation where the donor may recommend eligible charitable recipients for grants.

AFFILIATE FUND

Local fund affiliated with a foundation.

AGENCY ENDOWMENT

A fund established within a community foundation or other public foundation by a nonprofit organization.

ANNIVERSARY OR BIRTHDAY CAMPAIGN

A fundraising campaign centered around an anniversary date of an institution on the premise that the occasion will stimulate giving.

AREA OF INTEREST FUND

A fund that allows donors to direct funding to a particular cause or specific geographical area.

BEQUEST OR CHARITABLE DEFERRED GIFT

A donation made to a charity named as beneficiary under a will or trust.

CAUSE OR CAUSE-RELATED MARKETING

A partnership between a for-profit company and a nonprofit organization that increases the company's sales while raising money and visibility for the cause.

CHALLENGE, CONDITION OR MATCHING GIFT OR GRANT

A grant that is paid only if the nonprofit is able to raise additional funds from other sources.

CHARITABLE CLASS

The group of people that may legally receive assistance from a charitable organization. A charitable class must be large or indefinite enough that providing aid to members of the class benefits the community as a whole.

CHARITABLE DEDUCTION

The portion of a gift to a qualified charity that is deductible from an individual's

or corporation's federal income tax, individual's gift tax or individual's estate tax.

CHARITABLE GIFT ANNUITY

A contract under which a charity, in return for a transfer of cash, marketable securities or other assets, agrees to pay a fixed amount of money to an individual during his or her lifetime.

CHARITABLE LEAD TRUST

A trust that provides an income stream to a charity for a specified period of time. At the end of that period, trust assets are distributed to noncharitable beneficiaries such as children or grandchildren.

CHARITABLE REMAINDER TRUST

An arrangement in which property or money is donated to a charity, but the donor continues to use the property and/ or receive income from it while living.

COMMUNITY OR PUBLIC FOUNDATION

A nonprofit, publicly supported, nonsectarian philanthropic institution with a goal of building permanent funds established by separate donors for the broad-based charitable benefit of the residents of a defined geographic area.

COMMUNITY FUND

An organized community program that makes appeals to the public for funds to be used for the ongoing operational support of local agencies.

CORPORATE CITIZENSHIP

Business giving, including business relationships and partnerships with nonprofit organizations.

CORPORATE FOUNDATION

A private foundation that receives its funding from the for-profit company whose name it bears but is legally an independent entity.

CORPORATE GIVING PROGRAM

A grant-making program established and administered within a for-profit corporation.

CORPORATE VOLUNTEER COUNCIL

A network that businesses join to address community needs through workplace volunteering.

CORPORATE, EMPLOYEE OR WORKPLACE VOLUNTEER PROGRAM

A company-managed program that coordinates company staff with nonprofits looking for volunteers.

DEMONSTRATION GRANT

A grant made to establish an innovative project or program that will serve as a model. If successful it may be replicated by others.

DESIGNATED ENDOWMENT

Established by an individual, family or business to benefit one or more charities.

EMPLOYEE MATCHING GIFT OR GRANT

A program whereby an employee's contribution to a charitable organization is matched by a similar contribution from the employer.

ENDOWED FUND

A fund created by gifts that establish its principal, which then makes grants from the income generated by that principal. An endowed fund exists in perpetuity and continues to carry out the donor's wishes after death.

ENDOWMENT

A permanently restricted fund, the principal of which is protected and the income from which may be spent.

EVALUATION OR PILOT GRANT

A grant that supports the external evaluation of a project. With a successful project, the evaluation grant works as a leveraging tool, enabling the recipient to seek further funding.

FEDERATED FUNDER

A joint fundraising effort administered by a nonprofit "umbrella" organization that in turn distributes funds to nonprofit agencies. Examples include United Way, United Jewish Appeal and United Negro College Fund.

26 GLOSSARY of Nonprofit Terms

FLOW-THROUGH FUNDS

Contributions to a foundation that are used primarily for direct grant making rather than for endowing the foundation.

FOUNDATION

A public or private nonprofit corporation or trust that makes grants to organizations, institutions or individuals for scientific, educational, cultural, religious or other charitable purposes.

IN-KIND DONATION OR GIFT

A gift of goods or services rather than cash or property.

INITIATIVE-BASED GRANT MAKING

A grants program based on applicants responding to a request for proposals.

IRREVOCABLE TRUST

A gift in trust that cannot be rescinded.

LIMITED-PURPOSE FOUNDATION

A foundation that restricts its giving to one or very few areas of interest, such as higher education or medical care.

MEMORIAL OR NAMED FUND

A fund established by, or named for, an individual, family, corporation or other group to carry out the charitable interests of the donor or honoree.

NONENDOWED FUND

In contrast to endowed funds that can only make grants from interest income, a nonendowed fund's principal can be used for grants.

NONPROFIT

An organization established for activities other than profit making. Some nonprofits are exempt from federal income taxation, but they may be taxed on income from unrelated businesses they conduct.

Common nonprofits include: **50I C (3)**

A public charity or private foundation. Gifts to a 501 c (3) are tax-deductible.

50I C (4)

A social welfare or employees' association whose net earnings are used solely for charitable, educational or recreational purposes.

50I C (6)

A trade association or business leagues not organized for profit or private benefit.

50I C (7)

A social club organized for pleasure and recreation.

50I C (8)

A fraternal beneficiary society, order or association operating under the lodge system that provides benefits to members and their dependents.

50I C (I2)

A benevolent life insurance association, cooperative or ditch or irrigation company.

OPERATING FOUNDATION

A private foundation that uses the bulk of its income to provide charitable services or to run charitable programs of its own.

PARTNERSHIP FUNDING

A grant program where "partners" often government and philanthropic sources have input into the project.

PASS-THROUGH FOUNDATION

A foundation that receives funds and makes distributions with little or no principal remaining with the foundation.

PERPETUAL TRUST

A trust established with the intent to keep the principal invested in perpetuity and distribute the income from investments to one or more charities.

PROGRAM OR PROJECT GRANTS

Funds to support specific projects or programs as opposed to general support grants.

PROGRAM RELATED INVESTMENT

A loan (not a grant) made by a foundation to another organization for a project related to the foundation's interests.

RESTRICTED ENDOWMENT INCOME

Income from a permanent fund used for a specified purpose.

RESTRICTED FUND, GIFT OR GRANT

Money given with donors' specifications on how a nonprofit may use it.

REVOCABLE TRUST

A trust that can be recalled by its creator. Revocable trusts become irrevocable when their creators die and can become irrevocable sooner if the creators give up the power to revoke.

SOCIAL ENTERPRISE

A nonprofit venture that combines the passion of a social mission with the innovation and determination commonly associated with for-profit businesses.

SOCIAL ENTREPRENEUR

An individual who engages in social enterprise, drawing upon the best thinking in both the business and nonprofit worlds.

SOCIAL VENTURE FUNDS

Charitable funds in which donors invest their expertise as well as their money, providing support and requiring accountability of nonprofit organizations just as venture capitalists do in business enterprises.

SOCIALLY RESPONSIBLE INVESTING

The practice of aligning a foundation's investment policies with its mission. This may include refraining from investing in corporations with products or policies inconsistent with the foundation's values.

UNRESTRICTED FUND

A fund that is not specifically designated for a particular use by the donor, or for which restrictions have expired or been removed.
