

Conflicting regulations, clashing priorities

Does the state have the final say, or should local governments?

Relationships between oil and gas companies and Northern Colorado have taken a decidedly chilly turn this year as calls for tighter regulations echo across the region.

Except for in Weld County. While moratoriums cropped up in one municipality after the next, Weld remained a friendly locale for oil and natural-gas drilling.

"Weld County is considered a very good place to do business," said Tisha Conoly Schuller, president of the Colorado Oil & Gas Association.

That's because the county has let the state take the lead on permitting for oil and gas development. That hasn't been the case in a growing number of other communities.


Loveland, Erie, Longmont, Boulder County, Colorado Springs and other areas went so far as to pass drilling moratoriums while they review their regula-

tions. Fort Collins was considering an eight-month drilling ban.

Fort Collins has not updated its drilling laws for years, said Karen Cumbo, director of Planning Development and Transportation. A moratorium would give the city the chance to review issues such as access roads, floodplains, buffers, noise and water and air quality.

"We really don't have much of a process in place to deal with it," she said. "Nor do our land-use regs really reflect both the current industry technology or current public concerns about it."

How far Fort Collins might be allowed to go is up in the air.





The state Attorney General office has sent letters cautioning local governments to avoid passing oil and gas laws that clash with state regulations.

El Paso County, which received one of those letters in January, was told that it should abandon its proposed rules because they conflicted with the Colorado Oil and Gas Conservation Commission's "regulatory regime." The letter cited conflicts in laws regulating setbacks, wildlife, noise and lighting.

"Exhaustive local regulations are unnecessary," the letter read.

Conflicting local regulations, in fact, now top the list of priorities for the state oil and gas lobby, Conoly Schuller said.

> She explained that onerous local regulations on top of the state's already stringent set of laws have forced some smaller oil and gas companies to postpone decisions on whether to locate rigs in Colorado.

> Gov. John Hickenlooper's administration responded earlier in the year by forming a task force aimed at helping clarify regulatory jurisdiction between state and local governments on oil and gas development.

The task force was supposed to address noise, wildlife protection, distance of drilling from buildings, traffic, air quality and other issues.

"This is an important step to better

define state and local jurisdiction regulatory structures as Colorado's oil and gas industry continues to grow," Hickenlooper said in announcing the formation of the task force.

In its report, the panel did not call for new laws or changes to old ones to clarify how energy operations should be regulated in the state, but rather recommended "a collaborative process through which issues can be resolved without litigation or new legislation."

That, however, didn't stop Loveland or Fort Collins from passing or considering at least

temporary bans while they reviewed their own regulations, just as the town of Erie did earlier in the spring.

Erie's Board of Trustees passed a six-month prohibition on oil and gas drilling in March.

The ordinance does not affect current wells, but additional drilling applications will not be accepted.

The moratorium followed a study indicating that Erie, a town of 18,000 people that straddles Weld and Boulder counties, contained significantly higher levels of certain kinds of pollution associated with oil and gas development than either Hous-

ton and Pasadena, Calif.

While the moratorium is in place, the town will review its oil and gas development code to enact possible changes, town spokesman Fred Diehl said.

Even before the moratorium, town officials were meeting with representatives of Noble Energy Inc., Anadarko Petroleum Corp. and Encana Corp., as well as state Oil and Gas Conservation Commission officials, to discuss a local drilling agreement.

The town wants that local agreement to supplement state regulations, Diehl said.

"It is fair to say that the town of Erie is pushing the limits of local authority," he said. "We do that ... to make sure we can provide the greatest degree of protection in terms of human health and the environment."

As communities like Erie weigh their own regulations, the oil and gas industry fears a patchwork of complicated laws.

Companies already follow "hundreds" of state regulations to maintain air and water quality, Schuller said. Air-quality regulations present the No. 1 permitting challenge for producers.

"It would just be overwhelming to meet all the current requirements and then additional local regs as well," she said.

The state already does a "good job" of regulating the oil and gas industry in Colorado, Encana spokesman Doug Hock said. Encana drills natural gas wells near Erie.

On the other hand, "counties and municipalities do have concerns that need to be addressed," he said. "That's the challenge really at more of a state and local level."

That's why Encana has worked with Erie to develop a set of guidelines that the company will follow when drilling in town limits.

As for other regulations, Encana tries "to go above and beyond those where we can" by adopting methods not yet required by state law, Hock said.

As an example, the company uses "closed-loop" systems to capture drilling fluids from hydraulic fracturing in tanks. Also known as fracking, the method involves pumping water, sand and chemicals into a drilled area to release natural gas from shale.

Encana also tests water before and after drilling in areas where people own wells to determine its quality and quantity.

"We try to stay ahead of the curve on regulations," Hock said. That, of course, might not be enough.

Oil and water: The right mix?

The facts on how much H₂O oil and gas producers really use

veryone agrees hydraulic fracturing uses a lot of water, but is it so much as to cause alarm?

The raw numbers sure sound worrisome: tens of millions of gallons a year.

But what's the context? Are the oil companies leaving Colorado high and dry? Has all of the fracturing going on across Northern Colorado diverted that much water from our farmers? Will children need to learn to brush their teeth with a lot less swishing and spitting?

As it turns out, the numbers aren't quite what they appear. Water use in fracturing makes up less than 1 percent of Colorado's total annual water consumption, according to a Colorado Oil and Gas Conservation Commission report.

The largest water users by far are, as you might imagine, farmers.

Still, ever-sensitive to their image, oil and gas companies are studying how they can cut their water consumption.

They're also recycling a greater amount of water that they use.

An oil or gas well drilled horizontally can require anywhere from 2 million to 5 million gallons of water. Also known as fracking, the technique involves pumping water, sand and chemicals into a drilled area to release oil and natural gas from shale.

Annually, about 13,900 acre-feet of water are used in fracturing in Colorado. An acre-foot equals about 326,000 gallons.

If that sounds like a lot, it is.

On the other hand, at least 16.4 million acre-feet of water is consumed in Colorado every year. Actually, that figure is a conservative estimate, given that a large number of groundwater wells throughout the state are not factored in.

Meanwhile, an additional 10 million acre-feet of Colorado water each year end up in other states.

Despite these figures, environmentalists contend there is not enough water available in Colorado for fracking, especially as cities consider large water projects that will put additional pressure on supplies.

The numbers don't support them. By 2015, the state oil and gas commission projects water use in fracturing will grow to only 18,700 acre-feet.

And compared with uses by industries such as agriculture, which consumes more than 85 percent of the state's water, oil and gas development water use remains practically insignificant.

"In terms of the grand scheme of things, it's a small amount," said Brian Werner, spokesman for the Northern Colorado Water Conservancy District in Berthoud. A wholesale water provider, the NCWCD does not sell water to oil and gas companies directly, but its municipal customers do.


Moreover, competition for water is not nearly as fierce as some have portrayed.

After a recent auction of unallocated water held by the district, several reports accurately stated that frackers bid






more for the water than farmers.

What those reports failed to note was that more than 90 percent of the water went to farmers and cities (84 percent to farmers and 8 percent to cities), Werner said. Only 8 percent went to industrial customers, including oil and gas development companies.

Everyone who bid for the water got it with the exception of one person who submitted a low bid, Werner said. Further, the average successful bid for water sold at the annual auction has decreased the past three years, despite erroneous reports saying the price had surged.

"In my mind, it's pretty hard to draw the conclusion that the frackers who come into that auction this year have driven the price up," he said.

New water uses, of course, can strain a system where water rights already are allocated, said Ken Carlson, a CSU professor of environmental engineering who is studying water use by oil and gas companies.

That said, "if we do the proper planning, it shouldn't greatly impact or impact at all the way we're using water in the state," Carlson said.

Part of that planning involves finding ways oil and gas companies can limit their water use.

At CSU, Carlson and other researchers are working with Noble Energy Inc., one of the larger oil companies active in Northern Colorado, to study water-management issues.

One of those issues is how companies can recycle more of their water. It's something that oil producers in other places throughout the state already are doing.

"The industry is aggressively looking at how best to recycle water," Carlson said.

Currently, companies inject most of their used water into holes drilled 10,000 feet into the ground. They sometimes let the water evaporate in open pits, though that technique is not used as often.

Besides recycling, studies have focused on what kind of drilling techniques use less water.

Encana, which drills natural-gas wells near Erie, recycles more than 95 percent of water used in its Western Slope operations, spokesman Doug Hock said.

In the Denver-Julesburg Basin, the company is recycling 210,000 gallons of water per week through a pilot program, Hock said. The recycling program is part of an overall water-management plan through which the company aims to reduce its fresh water use.

Encana wells produce about 92,400 gallons of water daily that rise with natural gas, he said. It treats almost two days' worth of that water and reuses it for hydraulic fracturing, reducing the amount of fresh water consumed.

It still has a long way to go, though. The company consumes an average 880,000 gallons of water per well during hydraulic fracturing, he said.

Saving water isn't just about doing the right thing.



The more the oil companies can recycle, the lower their drilling costs.

And, as Hock said, "if we can recycle, it reduces the demand that we're putting on the overall (water) supply."

Not to mention perhaps helping to reduce the rhetoric.

Gassing up at the power

company

Utilities slowly turn to a cleaner alternative to coal

Tri-State announced last fall it had agreed to purchase this 272-megawatt natural gas-fired combined cycle power plant in Fort Lupton.

ast fall, when a 272-megawatt natural gas-fired power plant in Fort Lupton was put on the market, Tri-State Generation and Transmission Association Inc. jumped on the deal.

A wholesale power supplier based in Westminster, Tri-State provides power for and is owned by 44 electric cooperatives, including the Poudre Valley Rural Electric Association. The association wasn't necessarily shopping for new plants at the time, but the offer was "an unforeseen opportunity" to increase

its natural-gas power, said Brad Nebergall, Tri-State senior vice president of energy management.

The association's increased stake in natural-gas is part of a growing national trend fueled by cheap natural-gas prices and promising forecasts for plentiful supplies.

The trend also is getting a push from regulators who want to limit emissions that contribute to climate change, haze and health problems such as respiratory illness.

The U.S. Energy Information Administration projects natural gas will account for 82 percent of new energy capacity in the country in 2013, way up from 42 percent this year.

Coal-burning facilities, meanwhile, are expected to slip to 10 percent of total new capacity in the U.S. in 2013, down from 18 percent in 2009, the U.S. Energy Information Administration reports.

With oil-extraction processes, namely hydraulic fracturing, raising concerns over pollution and contamination of air and water, the comparatively clean-burning profile of natural gas is reshaping electric companies' short- and long-term plans.

On the flip side, market softening for natural gas also poses challenges for Tri-State and other utilities and state governments. Natural-gas prices this year have sunk to their lowest levels in a decade, which has meant lower revenues for Tri-State.

In late April, Wyoming Gov. Matt Mead called for an 8-percent state budget reduction to save \$74.5 million because the state primarily relies on natural-gas production for its revenue. The steep drop in gas prices could cost Wyoming as much as \$125 million, according to the governor's office.

Those market fluctuations hint at the volatility for the

commodity, said Brian Moeck, the outgoing general manager of the Platte River Power Authority, which supplies electricity to Fort Collins, Loveland, Longmont and Estes Park.

So, he said, while the record supply and prices of natural gas are intriguing at the moment, the power authority isn't about to abandon its fossil-fuel operations.

Platte River produces roughly 80 percent of its energy via the Rawhide coal-fired power plant and another coal plant near Craig. In 2009, natural gas accounted for just 0.3 percent of the company's energy supply to the four cities it serves.

That's not likely to change much, because power generation from coal is still roughly four times cheaper than generation

from natural gas.

On the other hand, the power authority's plans do call for building a new natural-gas power unit in the next 10 years, along with additional renewable energy supplies.

Also, Xcel Energy Inc. in the past year announced plans to close a coal plant in Boulder and convert facilities at the Cherokee power plant in Denver to run on natural gas instead of coal. The \$1.3 billion conversion was \$225 million cheaper than installing pollution-control equipment.

Many big coal-burning utilities have invested billions on pollution-control equipment on their largest coal-fired plants. But they are replacing or idling smaller coal plants for which such expenditures can't be justified.

As gas supplies remain abundant and prices stay low, climate-change concerns are expected to further accelerate the gas-power boom and long-term utility plans.


And if a carbon tax or other climate-related regulations raise the costs of operating coal plants, natural gas, which releases less carbon and burns more cleanly than coal, could quickly become the preferred energy source.

"It's the biggest game-changer on the horizon," Tri-State's Nebergall said of a potential carbon tax. "We're watching it real closely."

For now, natural gas represents about 25 percent of Tri-State's generating capacity.

Meanwhile, gas development is having one more impact on Tri-State's growth: In 2010, the company's load increased 5.5 percent, three times faster than the average growth rate of U.S. electric utilities.

The spike in demand, Nebergall said, was "largely driven by industrial development in the rural communities served by electric cooperatives," referring mainly to natural-gas exploration and drilling in the areas it serves, including northern and eastern Colorado.

Big plays, big profits

A look at some of the largest operators in the Niobrara

Northern Colorado's Niobrara shale formation has been producing oil since the late 1800s, but, as most anyone in these parts can tell you, 2009 was the year Niobrara put the region on the oiland-gas exploration map.

In October of that year, EOG Resources drilled the Jake well and a year later it was steadily pumping out 2,500 barrels per month, compared with a national average of 300 barrels per well. At the end of 2010, Noble Energy's Gemini well had produced 32,000 barrels over a six-month period.

Now, the Niobrara, which is part of the larger Denver-Julesburg Basin, is being compared with North Dakota's highly productive Bakken shale oil and gas region. Most of the Niobrara activity is clustered around Northeastern Colorado and across the border into Wyoming.

Weld County in particular is the spot to be for oil and gas producers. North-central Colorado's Wattenberg field, also part of the Denver-Julesburg Basin, is another promising area drawing lots of attention.

Given the oil and gas world's growing interest in Northern Colorado, it makes sense to step back and take a look at the major players.

Figuring out who they are, however, isn't just a matter of seeing who has the most wells, rigs or permits.

The companies themselves aren't particularly talkative when it comes to plans for the region, most likely because they don't want to tip off the competition.

Based on conversations with government regulators, industry officials and trade association

spokespeople and a look at what the outside experts are writing, three companies emerge as Niobrara's top players – EOG Resources Inc., Noble Energy Inc. and Anadarko Petroleum Corp.

Following close behind are two of what we'll call "honorablemention" contenders. Here is a quick look at the big three, in no particular order, followed by a roundup of the honorable mentions.

EOG Resources Inc.

Since EOG's Jake well is credited with starting the rush to Northern Colorado, it makes sense to start with this company. EOG spokespeople, as was the case with the other two big three, declined to answer direct questions and instead pointed to U.S. Securities and Exchange Commission filings and analyst conference-call transcripts.

Those SEC documents show that Houston-based EOG's revenue grew from \$6.1 billion in fiscal 2010 to \$10.1 billion in fiscal 2011.

The company also said it is increasing resources for oil exploration and production and decreasing those resources for natural-gas production because of declining natural-gas costs.

Given that the Niobrara is thought to be rich in oil and liquid natural gas, that shift in resources could be good for the region.

Liquid natural gases such as propane and butane are trading at higher prices than "dry" natural-gas, the refined, almost pure methane product used to heat homes.

According to oilshalegas.com, an oil and gas industry web site, EOG has three successful wells in the Niobrara. According to various articles from oil and gas industry experts, EOG has 220,000 acres in the Niobrara, and 76 percent of that acreage has proven viability for drilling.

As for the Jake well that kicked off the land rush, Mark Papa, EOG CEO, said during a conference call with analysts that the well is producing 275 barrels per day, down from its peak but demonstrating a low decline rate.

Noble Energy Inc.

Noble has leases on 860,000 acres in the broad Denver-Julesburg Basin with 190,000 of those acres in Northern Colorado, primarily in the Wattenberg field.

According to its SEC filings, the Houston-based company plans to invest some \$8 billion in the Denver-Julesburg Basin between now and 2016.

Currently, the company is pumping 62,000 barrels of oil equivalent (BOE) per day in the region.

Noble thinks its Denver-Julesburg holdings could yield a total of 1.3 billion barrels of oil. In 2011, the company drilled more than 85 horizontal wells and it plans to double that pace in 2012.

During the third quarter of 2011, the company drilled an average of eight horizontal wells per month, double its pace at the end of the second quarter.

In the Niobrara alone, yields from horizontal wells were up to 14,500 BOE per day, up 64 percent from the end of the second quarter.

Noble also said it plans to add acreage in Northern Colorado, but at a more controlled pace than in recent years.

In its last fiscal year, Noble's revenue increased to \$3.7 billion from \$3 billion the year earlier.

Anadarko Petroleum Corp.

In mid-November, Houston-based Anadarko released an update on its Niobrara operations. At that time, the company had 11 horizontal wells that were achieving strong initial results and high liquids yields.

The company expects to drill in 1,200 to 2,700 future locations and estimates ultimate yields of 300,000 to 600,000 BOE per well. Ultimately, the company expects a net yield out of Niobrara of 500 million to 1.5 billion BOE.

Chuck Meloy, Anadarko senior vice president of worldwide operations, said initial rates from Niobrara wells are averaging 800 BOE per day, which is considered very promising.

Anadarko bills itself as the largest net producer in the Denver-Julesburg Basin with production of 70,000 BOE per day.

The company has 900,000 acres throughout the broader basin, with 350,000 acres in the Wattenberg field. It has 5,200 wells in that field. This year, the company plans to drill an additional 160 horizontal wells, up from 40 in 2011.

Meloy said the Wattenberg field is proving to be among Anadarko's most cost-efficient projects in its U.S. onshore portfolio.

Anadarko posted revenue of \$14 billion in fiscal 2011, compared with \$11 billion in fiscal 2010.

Honorable mentions

Two other companies ranked highly, according to sources, but weren't considered in the top three.

Calgary, Canada-based Encana Corp. has 48,000 acres in Northern Colorado and five wells producing 260 to 540 BOE per day and 100 to 200 BOE per day of liquid natural gases. The company has identified another 200 drilling sites.

Oklahoma City-based Chesapeake Energy Corp. at the end of 2011 announced it was selling a 33.3 percent interest in its 800,000-acre Denver-Julesburg Basin holdings to Hong Kongbased CNOOC Ltd. Its 16 wells in the basin are producing 1,000 BOE and 3 million cubic feet of natural gas per day. The company plans to have 20 rigs operating in the basin by the end of 2012, up from 10 at the end of 2011.



A new messenger makes her mark at COGA

Fighting for fracking

T isha Conoly Schuller has plenty of time to reflect on her hour-long commute from her log cabin in Gold Hill to her office in Denver. As the president and CEO of the Colorado Oil & Gas Association, she has plenty upon which to reflect.

Conoly Schuller is three-plus months into her third year leading COGA, and despite the challenges of the job, her sense of humor remains intact. When asked whether she considers her tenure a success so far, she

> said, "If public concern over fracking is any reflection, I should be immediately replaced!"

> > Fortunately for Conoly Schuller, her 40-member board of directors disagrees with her.

"Tisha is a whirlwind of energy," said COGA board chair Scott Moore, vice president of marketing at Anadarko Petroleum Corp. "She has provided a much-needed different face of the industry. She has a strong sense of connection with the environmental community and finds ways to identify a common ground between our values and theirs."

Moore's optimism aside, the contention around shale gas mining keeps Conoly Schuller awake at night. She's convinced solutions can be found to improve the dialogue about the controversial energy extraction process that has so divided industry and communities across the nation. While it's hardly her only challenge — moratoria on new drilling permits

continue to pile up across Colorado — it's the hot button upon which she was hired to pour cold water.

"All the misinformation about the (shale gas) industry that is

out there — it's hard to counter that with sciencebased facts," she said. "That's a long-term process. On the other hand, the industry has not connected well with public emotion about the issue. Part of my style is to cultivate an empathy and understanding with the opposition. We also are parents and users of forests. (She has two children who live with her in that cabin in Gold Hill.) A lot of my job is connecting those things."

Conoly Schuller was attempting to explain this to shale gas industry executives in September when she inadvertently stirred things up again. As the keynote speaker at a conference entitled Enhancing Shale Oil & Gas Development Strategies, she exhorted those in the audience to adopt a more open, more realistic dialogue with the "nuts" who opposed fracking.

Her message was that these were not nuts, but in fact the vast majority of citizens in communities impacted by fracking. But her words got picked up by fracking foes who used them to further excoriate the industry for its alleged head-in-the-sand attitude toward concerns raised about the extraction method.

"What I was trying to explain was that these are not concerns of the fringe," she said. "A mainstream population is concerned with this, not just a fringe. The challenge is we have too many independent echo chambers. We reinforce our own vision of reality. We know the drilling can be done safely. So it's easy to dismiss someone's concerns. We need to acknowledge the emotion but engage at a level of science and fact."

What's frustrating to Conoly Schuller is that she comes from the environmental side of the coin and believes that she has thoroughly reviewed the science behind fracking and knows that it can be done safely.

"The misinformation is much more prevalent than the factbased information," she said. "It's heart-breaking for me that the technology that allows us to get so much energy for so little environmental degradation is being held back. We'll continue

and ultimately the facts will prevail. It will take years for the conversation to evolve, but we will prevail. In the end, this is responsible energy development."

Of course, her critics would beg to differ. But she has been slowly, surely engaging them in dialogue, said Anadarko's Moore. And the COGA board has confidence in her ability to change the nature of the oil and gas exploration conversation in Colorado. "If anyone can do this, it's Tisha," Moore said. "She is not what you expect from the president of a trade association when she walks into the room."

Conoly Schuller grew up in a working class neighborhood in Tucson, Ariz. She got early lessons in self-reinvention. Her mom got a mid-life doctorate in psychology, and her stepdad, a Baptist minister, went to medical school and became a physician in his mid-50s. Conoly Schuller received a near full-ride to Stanford University ("I was sure it was a mistake but I wasn't gonna tell them that") where she distinctly heard a career in environmental sciences calling her name.

She landed a job in the San Francisco Bay Area out of school, and within a few years found herself transferred to Boulder to open an office for an environmental consulting firm.

"I was 25, had a dog and a pickup truck and there I was in Boulder. I was completely unprepared for the job, but that didn't faze me. It was a blessing and I am here to stay," she said.

Her resume zig-zags wildly from consulting firm to consulting firm. She opened new offices, carved out new turf, handled a turnaround situation ("I discovered that's what I really like to do") and generally built a reputation as an expert in oil and gas project management.

Then a beleaguered COGA came calling.

"When I took the COGA job it was such a stretch. It was not like anything I had ever trained to do. It involved lots of media and politics, all pretty much new to me," she said. "I am an environmentalist and I felt like the public conversation didn't reflect what I knew about the industry. I think I can be a translator."

She's already scored some impressive victories in her role as association leader.

She helped formulate, with the governor's office, a rulemaking process for disclosure on hydraulic fracturing.

She has spearheaded a highly successful, statewide voluntary baseline water sampling program that is designed to measure water quality before and after drilling.

And recently, in her ongoing campaign to turn the industry's communications strategy around, she created a new community outreach position.

Sarah Landry, whom Conoly Schuller hired for the job, had already visited every Colorado community with oil and gas operations in her first month on the job. "She's definitely high energy," Conoly Schuller said.

Can the industry truly change the dialogue around fracturing in Colorado?

Conoly Schuller thinks so, but cautions that it could take several years.

She's already thinking ahead to new challenges: she'd love to run her own oil and gas company, and sees that happening in the next five years — once she gets that fracking fracas resolved.

Q&A with Tisha Conoly Schuller, president and CEO, COGA

Question: How would you describe your leadership style? Are you comfortable setting an organization's agenda and strategic direction, or do you develop them with your team through a consensus process?

I like to think of my leadership style as a balance between visionary and pragmatic. I am motivated by the opportunity to lead an organization in a completely original direction, but I am fundamentally a get-things-done type of person and am always seeking actual, meaningful accomplishment.

I believe in surrounding myself with people different and more talented than I am, and using those unique characteristics, experience, and styles to develop an organizational strategic direction that is better than any of us could have developed alone. In the case of COGA, we have both the board of directors and the staff from which to draw talent and ideas, and I strive to make the most of all the



great characteristics with whom I have the great joy to work.

Q: Have you always tended to be a leader? Can you cite some examples from your past of your leadership qualities?

I've always been bossy and ambitious, (but) I've only recently grown into a leader. My leadership path has not followed a linear path: I was student body president in high school and perhaps peaked as ultimate Frisbee co-captain in college. Since then I have always tried to add value in any job I serve, which is code for wanting to be in charge wherever I am. I've managed offices and operations, and I probably enjoy turning around struggling businesses the most.

Q: Who has helped shape your career and your management style? How influential were your parents in this regard? Who were your most important mentors?

I am thankful for many mentors along the way, but I probably have to say that I learn the most from my failures. Q: What are some of your success stories at COGA?


I'm most proud of COGA's evolution into a sought-out voice on industry perspectives and information. This has been a slow and systematic effort, from developing an internal culture of finding and relying on facts, to creating information resources, to proactively communicating industry information to business and regulatory leaders.

An instance that shows how I address an issue: Recently when the governor was critiqued for appearing in COGA public service announcements, I spent two sleepless nights critiquing the PSA, the request we made of the governor, and the concerns of the environmental community. I evaluated each step, what I could learn from it, and how I could do it differently next time. In the end, I'm extremely proud of the PSA and the positive, pro-Colorado message it embodies. But I am always eager to learn and improve.

Q: What do you consider the greatest challenges that you face today at COGA?

Public misinformation. It tortures me that families living in areas that are or may experience oil and gas development are scared based on distorted half-truths. There are plenty of real-world issues to discuss about oil and gas development in a community, and I embrace those. But the quantity of terrifying misinformation is truly awful. It's so easy to state an untruth in 15 seconds. It takes so much more to correct it.

Loan decisions made close to home. It just makes sense.



Natural gas: How low will it go?

Producers hope for a reversal of fortunes

Natural-gas prices have been plummeting and aren't expected to come up anytime soon.

That's putting a big squeeze on Northern Colorado's naturalgas producers and has forced them to cut back on exploration and production while they wait for demand to catch up with supply.

When that might happen is uncertain.

But when it does, Northern Colorado will be poised to benefit, said Katie Jolly, an analyst with energy analytics firm Ben-Tek.

"The gas is still there, and we know how to get it," she said. "Then we can definitely turn production back on."

For now, however, it's a classic supply-and-demand dilemma straight out of Economics 101, said Don McClure, VP of government regulatory affairs at Calgary, Canada-based Encana Corp., one of Northern Colorado's leading natural-gas players.

And unless production actually declines and demand fails to rise, the price of natural gas, which has been halved over the past two years, could fall further.

Citigroup commodities analyst Anthony Yuen says the price of natural gas – now \$2.08 per 1,000 cubic feet – could briefly fall below \$1.

"There would be no floor," he says.

McClure also noted that while there are regional variations at

play, Colorado's gas industry moves very much in sync with the national picture.

"There has been a significant tightening in natural gas prices vs. where we were a year ago," Jolly said.

Another factor in the sluggish natural-gas market, McClure said, is the amount of natural gas in storage. A year ago, there was 2.4 trillion cub feet in storage in the U.S. Today, that number stands at 2.9 trillion, McClure said.

"Producers are shifting their focus from gas to oil," McClure said. "There is a correction under way."



Industry players say a correction in the market is under way.

Over the past five years, he said, supplies of natural gas have gone up thanks to horizontal drilling technology that led to higher natural-gas yields. In so-called shale gas plays, drilling technology has increased natural-gas well production by up to

six times, McClure said.

Last year, the U.S. produced an average of 63 billion cubic feet of natural gas per day, a 24 percent increase from 2006. Consumption, however, has grown only half as fast.

Supply is plentiful at the moment because temperatures this winter were among the warmest in more than 100 years.

Between November and March, daily natural-gas demand fell 5 percent, on average, from a year earlier, according to Bentek Energy. Yet production grew 8 percent over the same period.

"We haven't ever seen a situation like this before," Chris McGill, VP for Policy Analysis

at the American Gas Association, an industry group, told the Associated Press.

At the end of winter, there is usually about 1.5 trillion cubic feet of gas in storage. Today there is 2.5 trillion cubic feet because utilities withdrew far less than usual this past winter.

While producers aren't happy at the moment, their commercial customers are taking advantage of the low prices, including companies in the chemicals, plastics and fertilizer business. Cities running garbage trucks, buses and delivery vehicles are

using more natural gas. Also, electric utilities are switching to natural gas from coal.

Gas production companies are responding to the downward price pressure and increase in supply by cutting back on the number of rigs devoted to natural gas, McClure said.

Nationally, natural gas rig counts declined from 909 in January 2011 to 790 in January 2012. By early spring, that figure had declined to 670. In Colorado, natural gas rig counts declined from 57 in January 2011 to 48 in January 2012, according to Colorado Oil and Gas Association information. Last month, the count stood at 47.

Looking at the oil side of the equation, rig counts increased nationally from 793 in January 2011 to 1,208 in January 2012. For March, the figure is at 1,258. In Colorado, the oil rig count went from seven in January 2011 to 23 in January 2012.

"This resurgence in oil has been phenomenal," McClure said.

The flip side is that gas producers need to cut back production sharply to bring prices back up to sustainable levels.

Right now, he said, gas is trading at below break-even prices. According to information from investment bank Barclay's, the natural gas rig count will need to drop to below 500 in order for gas to start trading at \$4. McClure, however, feels gas needs to be above \$5 for production to come back in a meaningful way.

Many industry experts expect gas to approach the \$4 range

in 2013. Right now, traders are selling gas scheduled for 2014 delivery right at \$4.

Jolly said it might take until 2017 for natural gas supply and demand trends to push production back up.

Once that happens, Tisha Schuller, executive director of the Colorado Oil and Gas Association, said Northern Colorado, particularly in the Niobrara area centered around Weld County, may have a bit of an advantage because it is rich in liquid natural gases such as butane and propane, which enjoy higher prices. Niobrara is about 70 percent liquid natural gases, she said.

BenTek's Jolly also expects producers to shift resources toward regions such as the Niobrara that offer liquid natural gas and oil. In its fiscal 2011 earnings release, Encana stated that it's shifting its investments away from "dry" and toward liquid natural gases.

Looking at Northern Colorado, McClure doesn't expect the slump in gas prices to drastically cut into jobs, primarily because rig crews, which can run from 40 to 100 people, tend to stay with a rig whether it's pumping natural gas or oil. He does, however, expect to see some support jobs lost in Colorado's natural gas fields.

Regardless of what happens this year, or next, Northern Colorado's natural gas isn't going anywhere. It's just waiting for the market to swing.


